Claire Henry MBE is a registered Nurse who has over 30 years' experience in healthcare working in clinical, managerial, and quality improvement roles, mainly in Palliative and End of Life care services. Claire has led national programmes and independent reviews including the NHS End of Life Care Programme, the National End of Life Care Strategy for England, and a review of the National Choice offer for end-of-life care in England. Claire is a Visiting Researcher at the University of Cambridge Palliative and End of Life Care Research Group and a Visiting Fellow at the Open University. Claire is also a trustee at her local hospice.



Helen Bourner MA is an experienced NHS Director who has worked in acute and mental health trusts where she led a range of services including strategy, business development, stakeholder engagement, IT, communications and performance management. Helen's role will include co-ordinating the 'desk top' review, undertaking stakeholder conversations, writing the final report, liaising with our commissioner leads, and ensuring the overall project is delivered on time.
