

## Kieran Trippier Signed Football Shirts Charity Raffle Terms and Conditions



These Terms and Conditions are the Raffle Rules. By entering the raffle, entrants agree to be bound by these rules.

Thank you for supporting **Kieran Trippier Signed Football Shirts Charity Raffle**. The closing date is midnight on Sunday 25<sup>th</sup> February 2024. The draw will take place on Tuesday 27<sup>th</sup> February 2024. Any money received after the closing date will be treated as a donation.

Please be aware:

1. Credit card payments will not be accepted online or over the phone.
2. This is an online raffle only. This means;
  - a. No physical tickets will be issued.
  - b. An email confirming tickets purchased will be sent immediately as proof of purchase, followed by a further email before the draw is made indicating the purchaser's ticket numbers in to the draw.

3. The draw will be made using an online random number generator to determine the winners. The random number generator will be used to determine the winner of the Newcastle United signed shirt, followed by the winner of the England signed shirt.
4. No tickets may be sold to under 16s and the maximum number of tickets which can be purchased is 200 per person. If any ticket/s are unknowingly sold to a person who is under the age of 16, they will be exempt from the raffle, they will forfeit their prize and their entry money will be returned to them.
5. All tickets shall be priced at £1.
6. All raffle entry sales are final and no refunds shall be made at any time. All entrants acknowledge that their payment of £1 per ticket to enter the Kieran Trippier Signed Football Shirts Charity Raffle does not guarantee that they will win any prize.
7. Full payment for each ticket must be received in the form of cleared funds before the ticket can be entered into the draw. Only tickets for which full payment has been received in the form of cleared funds are eligible to win one of the prizes.
8. Winners will be notified by telephone, email or post no later than two weeks after the draw date.

12. In the event that an entrant changes their contact details, they will be solely responsible for advising St Oswald's Hospice Promotions Ltd of the change. Winners will be selected by St Oswald's Hospice Promotions Ltd drawn using an online random number generator. The results of the draw are final.
